Dear Florida,

This letter is to confirm that, following a mapping exercise, the Department of Accounting, Finance and Economics, Oxford Brookes Business School, Oxford Brookes University agrees to the following:

- 1) Students who are studying the BSc in Economics and Business programme can be admitted onto the second semester of the 2nd year of the BSc (Hons) Economics, Finance and International Business Degree providing they have met the following criteria:
 - a) Passed the first two years of the BSc in Economics and Business programme with an average of at least 8/10 overall
 - b) Adequate academic references from Faculty of Economics Sciences, International University of Struga tutors
- 2) All International University of Struga students progressing to Oxford Brookes University:
 - Must demonstrate English language ability with an internationally recognized qualification (IELTS with at least a 6.0 overall with a 6.0 in reading & writing and 5.5 in speaking and listening) or one of the following equivalent qualifications:
 - 1) Pearson Test of English with 56 overall and with 51 in all communicative skills
 - 2) TOEFL with 80 overall and with R20, W19, L19, S22
 - Any student who requires a Tier 4 visa (i.e. are resident outside the EU zone) would be required to be compliant with all UK Visa and Immigration requirements at the time of entry
 - Four modules need to be taken (60 credits: 15 credits for one level 4 module, 45 credits for three level 5 modules) in Semester 2 of the 2nd year of the of the BSc (Hons) Economics, Finance and International Business Degree


